### 7th CPC

The Government was very much eager to implement the anti-staff recommendations of 7th CPC; therefore issued Orders for fixation of Pay and Pension, with deadlines to effect payment of arrears alongwith revised payscale of month of August 2016.

The payment made and; staff watching the development of three member Committee Report likely to be submitted to Government in October 2016; regarding increase in fitment formula and raising minimum scale from Rs. 18,000/- so also the future of allowances.

Meanwhile, meeting with Staff Side and Secretary Department Side on 31st August for fitment formula and increase in minimum pay of Rs. 18,000/- disagreement is recorded.

On 1st of September 2016 meeting for future of existing allowance was discussed but, without fruitful result. In fact, all this exercise from Government Side is totally to confuse the staff. The NJCM took decision to differ the proposed Strike of July 2016 on the assurance that Committee will be formed and will submit its report within four months. But, the attitude of the Committee is noted above; and we will have to proceed on Indefinite proposed Strike from 11th of October, 2016.

We all CGE proved by observing One Day Strike of 2nd September, 2016 that we will not hestitate to go on Indefinite Strike in month of October 2016 to get the amended scale of pay, revision in fitment formula and better increase in existing allowances as we waited for last 10 years for better Pay Commission and again will wait for more 10 years for 8th Pay Commission. No it is not good. We came to this stage -

"You have to do or die and never to ask why."

## 7वां वेतन आयोग

सरकार 7वे वेतन आयोग को लागू करने के लिए उतावली हो रही थी, क्योंकि इस वेतन आयोग ने कर्मचारियों के वेतन में पिछले आयोगों के मुकाबले वेतन में कम बढ़ोतरी की है।

सारे देश में केन्द्रीय कर्मचारियों के वेतन बढ़ोतरी हो चुके हैं, किंतु इस अन्यायपूर्ण निर्णय के विरुद्ध कर्मचारियों में असंतोष व्याप्त है। NJCA द्वारा जुलाई 2016 अनिश्चितकालीन हड़ताल को नवंबर 2016 तक स्थिगत कर दिया गया है। क्योंकि सरकार द्वारा चार माह का समय मांगा गया है और कमेटी स्थिपित की गयी है जो 18,000/- मिनीमम वेतन तथा 2.57 फिटमेंट फार्मुला पर पुर्निवचार कर सरकार को रिपोर्ट देगी। उसी तरह सभी अलाऊंस पर आदेश रोक दिये हैं, उन पर पुर्निवचार कर निर्णय लिया जायेगा।

पता चला हैं कि कमेटी की मीटिंग 31 अगस्त को हुई जिसमें वेतन बढ़ोतरी तथा फिटमेंट फार्मुला पर कोई निर्णय नहीं हो सका। ता. 1 सितंबर को अलाऊंस विषय पर मीटिंग हुई किंतु कोई सकारात्मक बातचीत नहीं हुई।

इस 7वे वेतन आयोग की रिपोर्ट के खिलाफ संगठन की ओर से संघर्ष की जो रूपरेखा तय की गयी है। उसे कार्यान्वित करना ही अब हमारा कर्तव्य है। हम इस लड़ाई को आधे में नहीं छोड़ सकते। वेतन आयोग दस साल में एक बार और इस बार जो अन्याय किया गया है उसे दूर करना ही होगा अन्यथा और 10 साल वेतन आयोग के लिए रुकना होगा और तब तक यदि इसी वेतनमान और भत्तों पर दिन काटना हो तो यह एक घोर अन्याय होगा। इसलिए यदि अक्टूबर तक मिनीमम वेतन 18,000/- में बढ़ोतरी, फिटमेंट फार्मुला में बदलाव और सभी भत्तों की बढ़ोतरी इन मांगों पर सकारात्मक निर्णय नहीं होता तो अक्टूबर 2016 से अनिश्चितकालीन हड़ताल के सिवाय कोई दूसरा पर्याय नहीं है।
