

# **GDS** Committee

The Government denied the claim of GDS inclusion in 7th CPC. The Chairman 7th CPC categorically said to Union Representatives that Government has not referred the issue of GDS to Pay Commission. Though the Department of Posts wrote to the 7th CPC that GDS Employees are working at par with Departmental Employees and nature of work is one and the same for both categories. But the GDS were not included in 7th CPC and GDS Committee is announced.

However, the demand for appointment of a retired judge as Chairman GDS Committee is also not considered and a retired member of Postal Board Shri Kamlesh Chandra is appointed as Chairman GDS Committee and Shri T.Q. Mohammed, PMG, Agra is designated as Secretary GDS Committee.

Now Committee is called for the Memorandum from the Federations.

We have to chalk out the strategy and a common Memorandum from all the GDS Unions whether recognised or not recognised.

This is need of hour.

# **GDS** Committee

सरकार द्वारा GDS कर्मचारियों को 7वे पे कमीशन के दायरे के बाहर रखने का निर्णय केवल खेदजनक ही नहीं बल्कि वादाखिलाफी भी है।

डाक संबंधित मंत्री महोदय ने वादा किया था कि वे भरसक कोशिश करेंगे कि GDS कर्मचारियों का समावेश पे कमीशन में हो और डाक विभाग की ओर से इस आशय का पत्र भी चेयरमैन पे कमीशन को भेजा गया था। किंतु पे कमीशन ने स्पष्ट किया था कि सरकार की ओर से इस विषय में कोई सूचना प्राप्त न होने के कारण GDS के विषय को पे कमीशन के दायरे से बाहर रखा है।

इसके बाद संगठन द्वारा किसी रिटायर्ड जज साहब को GDS कमेटी के चेयरमैन के लिए मनोनित करने की मांग की गयी। उसे भी ठुकरा दिया गया और निवृत मेंबर पोस्टल बोर्ड श्री कमलेश चंद्रा को GDS Committee का चेयरमैन नियुक्त किया गया है तथा सेक्रेटरी के पद पर श्री टी.क्यू. मोहम्मद, PMG, आगरा को नियुक्ति दी गयी है।

चेयरमैन GDS कमेटी द्वारा फेंडरेशन को पत्र लिखकर मेमोरंडम भेजने के लिए एक माह की अवधि दी गयी है। समय की पुकार है कि हम सभी GDS यूनियन एवं फेडरेशन यदि मिलकर एक ही मेमोरंडम पेश करे तो सही कदम होगा ताकि हम GDS के साथ न्याय कर सके।

Sub: GDS union - Verification Process - 2016 - Reg.

Our affiliated union NUGDS applied to participate in the verification - 2016. Now the Department scrutinizing the applications. The list of applicant unions in GDS cadre will be issued by the Department in the middle (or) last week of April 2016. The Authorisation forms (declaration) will also be issued simultaneously. In this connection, our Federation affiliated unions NAPE-C, NUPM & MTS, & NUGDS General Secretaries alongwith Secretary General met at Raichur, Karnataka Circle on 20-03-2016. The following decisions were taken during the meeting.

- The joint CWC of NAPE C, NUPM & MTS, NUGDS will be conducted in every circle. The strategy to approach the verification process in each circle will be decided in the Joint CWC of Circle unions, according to need of local requirement of the concern Circle.
- 2. Incharge of each circles will be intimated later.
- 3. Our present position: According to RTI information our membership position as on 2015 December, is 30,000 (approx.) It is evident that we have good members in the base level. Further verification process our P3, P4, R3, R4 together submitted nearly 50,000 verification forms it shows we have good members in all cadres across the country. If A Cadres work jointly in the Circle level, we will get good membership in verification progress of GDS. Therefore it is decided that the P3, P4, Secretaries of each division should from NUGDS Division union in every division positively and they

should work together we will Secure 65000-750000 valued membership in the ensuing verification.

## Memorandum submitted to GDS committee:

FNPO & NUGDS jointly submitted the memorandum to the Kamlesh Chandra Committee. Secretary General FNPO, President FNPO met Chairman & Secretary of GDS Committee and discussed General issues. The committee chairman may call our union in the third week of April at any time, copy of the Memorandum already published in our website. The highlight of the Memorandum already sent to all Circles.

Appeal: All Circle Secretaries of P3 & P4 requested to translate the circular in the Regional language and Circulate in each division immediately and see that in each Division GDS union formed before the end of April 2016, nominating authorized office bearer cum Division Secretary of each Division should be finalized by the P3, P4 Circle Secretaries at the end of this month, wherever we have no branches, whereever we have branches don't change the Divisional Secretary at this stage it will create confusion in the verification process. We hope Circle Secretaries will work jointly with commitment in devoted manner to get maximum membership in the ensuing GDS verification.

# GDS आयोग

FNPO एवं NUGDS संयुक्त रूप से एक ज्ञापन 3/3/16 को आयोग के समक्ष प्रस्तुत किया जा चुका है जिसमें हम ने GDS के ज्यादा से ज्यादा मुद्दे को शामिल कर दिया है। इस ज्ञापन को तैयार करने में Group-C महासचिव श्री किशन राव का पूरा सहयोग भी प्राप्त हुआ है।

इस के साथ साथ ज्यादा से ज्यादा GDS कर्मचारियों द्वारा व्यक्तिगत तौर पर आयोग को प्रस्तुत करने के लिए हमने 53 मुद्दों वाला एक ज्ञापन तैयार करके सभी सर्कल एवं डिवीजनल सिचवों को प्रेषित किया था। आशा है सभी अपने अपने स्तर पर कार्यवाही किये होंगे। मेरा मानना है कि यह सुनहरा अवसर हमारे लिए एक वरदान है यदि हमने इस अवसर का लाभ नहीं उठाया तो हमारा भविष्य अंधकार में ही होगा। इसलिए मैं अपने पूरी ऊर्जा इस पर लगा रहा हूं। मेरा अनुरोध है कि आप लोग मेरे इस कार्य में पूर्ण रूप से सहयोग एवं समर्थन करें।

# GDS वेरीफिकेशन

वेरीफिकेशन प्रक्रिया शुरू होने के समाचार से आप लोग सभी विदित हो चुके होंगे। 31-03-2016 तक वेरीफिकेशन में शामिल होने के लिए आवेदन पत्र जमा करने होंगे। इसके बाद ही योग्यता पाने वाले यूनियनों का नाम तथा विवरण का घोषणा किया जायेगा। इससे पहले का परिपत्र में सभी को मैंने इस बारे में सूचित किया है।

2010 में NUGDS को 34804 सदस्य संख्या के साथ 13.16% प्राप्त था। कुल 3 यूनियनों के इस जनमत में हम दूसरे नंबर पर रहे। लेकिन 2016 हमें 4 यूनियनों से प्रतियोगिता करना पड़ सकता है, यह तो आप लोगों को बिना बताये ज्ञात तो होगा। इसलिए हमें दूसरे स्थान के साथ मान्यता प्राप्त मिलने के लिए कम से कम 65000-75000 तक सदस्यों का समर्थन प्राप्त करना होगा जो कि FNPO और NUGDS के अस्तित्व से भी जुड़ा है। क्योंकि FNPO की जो भी हड़ताल, आंदोलन तथा सम्मेलन को सफलता प्राप्त करने में GDS किमीयों की ही अहम् भूमिका रही है।

हमारे यूनियन में सदस्यों को शामिल करने में जो मुख्य बाधा वह यह है कि अनेक सर्कलों में डिवीजनल कमेटियां अभी भी नहीं है। लेकिन आश्चर्य की बात यह है कि इन डिवीजनों में Group-C कमेटी तो कार्य कर भी रहा है।

अतः मेरा सभी से खास अनुरोध है कि कम से कम इन डिवीजनों में अस्थायी कमेटियां को यथाशीघ्र गठित किया जाए। मेरा विश्वास है कि इससे हमारा लक्ष्य पूरा जरूर होगा।

- 3. डिवीजनों में हमारे यूनियन के आदशों में आस्था रखने वाले 3 व्यक्तियों को चुनकर उसमें से एक को सिमिति का संयोजक के तौर पर चुन लिया जाए और इस सिमिति की पूरी सूची संबंधित SSP/SP/SSRM/SRM को प्रस्तुत किया जाये। सूची में यह भी उल्लेख करें कि यही संयोजक भविष्य में वेरीफिकेशन संबंधी सभी पत्राचार में प्रधिकरण अधिकारी होंगे।
- इस पत्र को पंजीकृत एवं पावती डाक द्वारा प्रेषित करना है और एक प्रति राष्ट्रीय यूनिय को भी प्रेरित किया जाये।

यदि किसी भी सर्कल / डिवीजनों स्थायी समिति के गठन में कठिनाईयां आने पर, राष्ट्रीय यूनियन अपने आप अस्थायी समिति का गठन का निर्णय करेंगे और संबंधितों को सूचित करेंगे।

I am directed to forward herewith the Calendar of Departmental Examinations (Annexure) to be held in the year 2016 against the vacancies available.

- 2. The work of conduct of Postal Assistant Sorting Assistant DR Examinations has been entrusted to the Staff Selection Commission.
- 3. The centralised LDC examinations would be conducted after the engagement of the new agency.
- 4. The Circle will conduct the **Decentralized Examinations** as mentioned in the Annexure. **Necessary orders for paper setting of the decentralized examinations amongst various Circles will be issued separately by DE Section.** The Notification of holding the examination and calling for applications will have to issued by the Circles well in time as per the prescribed time limit of 40 days and the number of vacancies must be invariably indicated category-wise for the decentralized examinations. It may be noted that holding of these decentralized examinations involve entire work of the paper setting, Hindi translation, moderation, appointment of examiners, evaluation of answer sheets, making entries in tabulation sheets, declaration of result and deciding representations relating to the examinations and these all activities will be carried out at the Circle level.
- 5. It may please be ensured that the notification of the Decentralized Examinations is issued by the Circles positively within the stipulated advance period of 40 days and results

are declared within the specified period. In case of delay in the announcement of the result, the reasons for delay and the remedial measures that may be taken to avoid such delays in future may be brought to the notice of the Directorate.

- 6. Consequent upon introduction of RTI Act 2005, it has become compulsory to supply answer papers to the candidates on their request under the RTI Act 2005. To avoid grievances of the candidates about non-evaluation of any answer or striking wrong totals etc. it is advisable that before the result is declared, 100% verification of totals of all answer papers is done to ensure that totals have been struck currently and no answer has been left unevaluated. Candidate himself can re-total/verify personally on supply of answer paper; and there will be no need to entertain any request for retotalling/verification of answer papers by the concerned authority.
- 7. In cases where no vacancy exists or the examination is not likely to be held for any other reason(s), the fact should clearly be mentioned in the forwarding letter of the Calendar of Examinations to the subordinate offices. This may also be brought to the notice of the Directorate.
- 8. It may please be ensured that the Time Schedule, as indicated in the columns of the Annexure attached with the letter are strictly adhered to and timely action is taken at all stages without waiting for any reminder from this office.
