We with NFPE P-IV moved to Principal CAT and obtained stay, but unfortunately Directorate is adamant in the issue and we have to lodge case of Contempt of Court against Department.now the Department of Posts issued orders to all Chief Postmasters General to keep the orders in abeyance on abolition of posts in the circles.

DIRECTORATE Letter No.66-24/2013-SBP-I New Delhi Dated -13-12-2013

In case of payment of Bonus to GDS ceiling of Rs. 3500/- at par with Departmental Employees we have succeeded and for year 2012-13 the payment is made @ Rs. 3500/- to all GDS.

7th CPC has been announced by the Government of India. We have to prepare a good memorandum for submission to Chairman 7th CPC the name of which is to be nominated shortly before announcement of general election.

FNPO and NFPE decided to go on nationwide Indefinite Strike if the demand of inclusion of GDS for 7th CPC purview, regularisation of casual labour, part time, contingent employees and revision of their wages w.e.f. 1-1-2006 (as per 6th CPC wage revision) and grant of DA, merger of 50% DA with pay for all employees including GDS.

This decision has been taken in Central JCA meeting of FNPO and NFPE held on 19-10-2013 under the Chairmanship of Shri T.N. Rahate, President FNPO.

In the year 2014 India Post will be improving its technology through TCS. So everyone has to accept the change in technology and learn computer operations compulsorily.

We hope that we will succeed to get our demands settled with the new Government coming into power.

# CHARTER OF DEMANDS

## PART I GENERAL

- 1. Accept the terms of reference of 7th CPC, submitted by the staff side, National Council JCM.
  - (a) To examine the existing structure of pay, allowances and other benefits/ facilities, retirement benefits like Pension, Gratuity, other terminal benefits of various categories of Central Government Employees including Gramin Dak Sevaks (GDS) of Postal Department.
  - (b) To work out the comprehensive revised pay packet for the categories of Central Government employees including GDS as on 1.1.2014.
  - (c) The Commission shall determine the pay structure, benefits, facilities, retirement benefits etc. taking into account the need to provide minimum wage with reference to the recommendation of the 15th Indian Labour Conference (1957) and the subsequent judicial pronouncement of the honorable Supreme Court there-on, as on 1.1.2014.
  - (d) To determine the Interim Relief needed to be sanctioned immediately to the Central Government employees including GDS.
  - (e) To determine the percentage of Dearness allowance/Dearness Relief immediately to be merged with Pay and pension including GDS.
  - (f) To settle the anomalies raised in various fora of JCM.
  - (g) To work out the improvements needed to the existing retirement benefits, like pension, death cum retirement gratuity, family pension and other terminal or recurring benefits maintaining parity amongst past, present and future pensioners and family pensioners including those who entered service on or after 1.1.2004.
  - (h) To recommend methods for providing cashless/hassle-free Medicare facilities to the employees and Pensioners including Postal pensioners.
- 2. Ensure every five year revision of wages of Central Government Employees in future.
- 3. (a) Regularization of Gramin Dak Sevaks of the Postal Department and grant of Civil Servant status, statutory pension and all other benefits at par with regular employees.
  - (b) Regularization and revision of wages of casual and contract workers.
- 4. Compassionate appointment removal of restrictions imposed by Government.

- 5. JCM and Anomaly Committee Functioning.
- 6. Fill up all vacant posts and creation of new posts wherever justified.
- 7. Stop downsizing, outsourcing, contractorisation and privatization of Government functions.
- 8. Stop the move to introduce performance related Pay (PRP) system, Extend PLB Bonus for all, removing bonus ceiling.
- 9. Revise OTA and Night Duty Allowance rates and clothing rates.
- 10. Implement arbitration awards.
- 11. Five promotions to all.
- 12. Rescind the PFRDA Act. Ensure statutory Pension for all.
- 13. Grand MACP as per Apex Court judgment i.e. grand MACP on the basis of length of service in particular cadre ignoring the promotion got on competition examination.
- 14. Stop trade Union victimization. Ensure Right to Strike.

- 1 Grand Recognition to GDS Union as per Sri.P.S.Natarajamurthy committee recommendation.

## GDS Circle Welfare Fund : (Important points ) GDS Circle Welfare Fund

The guidelines for grant of Financial Assistance & Grant of Loan under Circle Welfare Fund for GDS has been issued by the Directorate vide lr. No.19-31/2012-WL/Sport dated 02-12-2013.

## **Important points**

- = All the regularly appointed GDS as on record will become the members under this scheme.
- = The GDS will have to fill in an application in prescribed format (Form-I) for joining in the CWFGDS and to submit the same in the Divisional office.
- = Leave substitutes & provisionally appointed GDS in leave arrangement are not eligible for the benefits of the Fund.
- = @ Rs.20- per month, a lumpsum of Rs.240- will be deducted in the monthly salary of every April.
- = From Govt. side @ Rs.100- per year for one GDS will be added to the Fund.
- = Applications should be sent through the Divisional Office.
- = A Regional level / Circle level committee will decide the sanction of grant / loan
- = Every quarterly months all the applications will be persuaded for sanction but not for death relief sanctions.
- = Terms & conditions will be applied for sanction of grant / loan.
- Recovery of Rs.120- has been made in the salary of October 2013 for six months (i.e, from October 2013 to March 2014)
- = Funds are also has been allotted to the Circles vide Lr. No.19-31/2012-WL/Sport dated 14-10-2013.
- = CWFGDS has three components for sanction of grant to GDS:
