ग्रामीण डाक सेवकों के वेतन ढांचे की समीक्षा के लिए समिति गठित

भारत सरकार द्वारा डाक विभाग में ग्रामीण डाक सेवकों के वेतन ढांचे, सेवा शर्तों इत्यादि की समीक्षा करने के लिए एक सदस्यीय समिति गठित की गई है।

डाक सेवा बोर्ड के सेवानिवृत्त सदस्य श्री कमलेश चंद्र समिति का गठन करेंगे। एक वरिष्ठ प्रशासनिक ग्रेड अधिकारी श्री टी. क्यू. मोहम्मद द्वारा समिति को सहायता प्रदान की जाएगी, जो जीडीएस समिति के सचिव के रूप में कार्य करेंगे। यह समिति ग्रामीण डाक सेवकों की सेवा शर्तों पर गौर करेगी और आवश्यक समझे जाने पर अहम परिवर्तन सुझाएगी। समिति के विचारार्थ अन्य बातों के साथ-साथ निम्नलिखित विषय भी शामिल होंगे -

- क) शाखा डाकघरों की प्रणाली, संलग्नता की शर्तों और ग्रामीण डाक सेवकों को भुगतान किए जाने वाले पारिश्रमिक एवं नामांकन की मौजूदा संरचना पर गौर करना और आवश्यक परिवर्तनों की सिफारिश करना।
- ख) ग्रामीण डाक सेवकों के लिए मौजूदा सेवा निर्वहन लाभ योजना/अन्य सामाजिक सुरक्षा लाभों की समीक्षा करना और आवश्यक बदलावों की सिफारिश करना।
- ग) ग्रामीण डाक सेवकों को प्रदान की जाने वाली मौजूदा सुविधाओं/कल्याणकारी उपायों की समीक्षा करना और आवश्यक परिवर्तनों की सिफारिश करना।
- घ) खासकर ग्रामीण डाकघरों में प्रौद्योगिकी को समाहित किए जाने के प्रस्ताव को ध्यान में रखते हुए ग्रामीण डाक सेवकों के रूप में संलग्नता के लिए न्यूनतम योग्यता, संलग्नता के तौर-तरीकों, उनके आचरण एवं अनुशासनात्मक नियमों पर गौर करना और कोई परिवर्तन सुझाना।

डाक विभाग में कुल मिलाकर 2.6 लाख ग्रामीण डाक सेवक हैं। जीडीएस समिति के दायरे में ये सभी जीडीएस आएंगे।

Subject : Setting up of one-man GDS Committee to examine the wage structure and service conditions of Gramin Dak Sevaks in the Department of Posts.

In accordance with the decision taken to set up a one-man Committee to examine the wage structure and service conditions of Gramin Dak Sevaks in Department of Posts vide Department of Posts Resolution No. 17-13/2013-GDS dated 19th Nov. 2015, the President is pleased to direct that Shri Kamlesh Chandra, retired Member of the Postal Services Board will constitute the Committee for a period of one year with effect from the date Shri Kamlesh Chandra assumes charge of his post, on the following terms and conditions:-

- (i) He will function on a full time basis.
- (ii) His pay, which together with pension and pension equivalent of other form of retirement benefits, will be restricted to last pay drawn minus pension per month.
- (iii) Dearness Allowance, as payable to officers of Central Government will be admissible.
- (iv) House Rent Allowance at the prescribed rate of pay will also be admissible.
- (v) Travelling Allowance/Daily Allowance may be paid according to his entitlement at the rate applicable prior to retirement.
- (vi) Conveyance facilities will be made available as admissible.
- (vii) The headquarter of Shri Kamlesh Chandra will be at New Delhi.
- (viii) He will be his own controlling officer.
- (ix) The expenditure involved in this connection will be debit to the Head 3201-Postal Services A1(1)(1) Postal Directorate (I) Salaries (Non Plan) and will be made from the sanctioned grant of 2015-16 and 2016-17.

2. No objection to the constitution of the GDS Committee was issued by Ministry of Finance, Department of Expenditure vide ID No: 1-4/2004-E.III (A) dated 14.10.2014 subject to the condition that the Terms of Reference of the Committee would be finalized in consultation with the DoPT and their Department. The Terms of Reference of the Committee were finally vested by the Ministry of Finance, Department of Expenditure vide U.O. No. 1-4/2014-E.III (A) dated 26.10.2015.

3. This issues with the approval of Secretary (Posts).

सं. 17-13/2013-जीडीएस.-ग्रामीण डाक सेवकों की सेवा शर्तों, परिलब्धियों और अन्य सुविधाओं की जांच के प्रश्न पर भारत सरकार काफी समय से विचार कर रही है। सरकार ने अब इस प्रयोजनार्थ एक सदस्यीय समिति के गठन का निर्णय लिया है। :-

2. श्री कमलेश चन्द्र, सदस्य (सेवानिवृत्त), डाक सेवा बोर्ड उक्त समिति के एकल सदस्य होंगे।
3. उक्त समिति ग्रामीण डाक सेवकों की सेवा शर्तों की जांच करेगी और यथापेक्षित परिवर्तनों का सुझाव देगी। समिति के विचारार्थ विषयों में अन्य बातों के साथ-साथ, निम्नलिखित विषय शामिल होंगे:-
 - (क) शाखा डाकघरों की प्रणाली, ग्रामीण डाक सेवकों की रोजगार संबंधी शर्तों तथा उनके मौजूदा मजदूरी ढांचे और परिलब्धियों की जांच तथा आवश्यक परिवर्तनों का सुझाव;
 - (ख) ग्रामीण डाक सेवक कर्मचारियों से संबंधित मौजूदा सेवा समाप्ति हितलाभ योजना/अन्य सामाजिक सुरक्षा लाभों की समीक्षा तथा आवश्यक परिवर्तनों का सुझाव;
 - (ग) ग्रामीण डाक सेवकों के लिए उपलब्ध मौजूदा सुविधाओं/कल्याण योजनाओं की समीक्षा और आवश्यक परिवर्तनों का सुझाव;
 - (घ) ग्रामीण डाक सेवकों के रूप में नियुक्ति हेतु भर्ती प्रणाली, न्यूनतम अर्हताओं तथा इनसे संबंधित आचरण और अनुशासन संबंधी नियमों की जांच और सुझाव, यदि कोई हो, विशेष रूप से ग्रामीण डाकघरों में प्रौद्योगिकी के प्रस्तावित समावेशन को ध्यान में रखते हुए।

4. समिति का कार्यकाल एक वर्ष का होगा और सरकार के विशेषाधिकार से इसे आगे बढ़ाया जा सकेगा।
 5. उक्त समिति के अध्यक्ष को श्री टी.क्यू मोहम्मद सहयोग करेंगे, जोकि विभाग के वरिष्ठ प्रशासनिक ग्रेड अधिकारी हैं। श्री मोहम्मद उक्त जीडीएस समिति के सचिव के रूप में कार्य करेंगे। डाक विभाग द्वारा उक्त समिति को पर्याप्त संख्या में सहायक कर्मचारी उपलब्ध करवाए जाएंगे। उक्त समिति 7वें केन्द्रीय वेतन आयोग के कार्यकाल के दौरान उसे अपने कार्य की प्रगति से अवगत कराती रहेगी।
 6. उक्त समिति अपने कार्य की प्रक्रिया स्वयं निर्धारित करेगी और किसी भी ऐसी सूचना तथा प्रमाण, जिसे वह आवश्यक समझे, की मांग कर सकेगी।
 7. उक्त समिति का मुख्यालय नई दिल्ली में स्थित होगा।

RESOLUTION**

New Delhi, the 19th November, 2015

No. 17-13/2013-GDS.- The question of examining the conditions of service and emoluments and other facilities available to the Gramin Dak Sevaks has been under the consideration of the Government of India for some time. The Government has now decided to set up a one-man committee for the purpose.

2. Shri Kamlesh Chandra, Retired Member of the Postal Services Board will constitute the Committee.
3. The Committee will go into the service conditions of Gramin Dak Sevaks and suggest changes as considered necessary. The terms of reference of the Committee will, inter alia, include the following:-
 - (a) To examine the system of Branch Post Offices, employment conditions and the existing structure of wage and emoluments paid to the Gramin Dak Sevaks and recommend necessary changes;
 - (b) To review the existing Service Discharge Benefit Scheme/other social security benefits for the GDS employees and suggest necessary changes;
 - (c) To review the existing facilities/welfare measures provided to the Gramin Dak Sevaks and suggest necessary changes;
 - (d) To examine and suggest any changes in the method of recruitment, minimum qualification for appointment as Gramin Dak Sevaks and their conduct and disciplinary rules, particularly keeping in view the proposed induction of technology in the Rural Post Offices;
4. The Committee will function for a period of one year, extendable at the discretion of the Government.
5. The Chairman of the Committee will be assisted by Shri T.A. Mohammad, a Senior Administrative Grade Officer of the Department, who will act as Secretary to the GDS Committee. Adequate staff support will be provided to the Committee by the Department of Posts. The Committee will keep the 7th Central Pay Commission informed of the progress of its work during the period of tenure of the Commission.
6. The Committee will devise its own procedure and may call for such information and take such evidence, as considered necessary.
7. The headquarters of the Committee will be at New Delhi.

Government Employees.

Reference : The Payment of Bonus (Amendment) Bill 2015.

Sir,

The Payment of Bonus (Amendment) Bill 2015 was passed by both the houses of the Parliament. The amendment provides that the existing Ceiling Limit of Bonus for 30 days Rs. 3,500/- is enhanced to Rs. 7,000/- for 30 days. This amendment will take effect from 01.04.2014 (A copy of the Bill passed in the Parliament is enclosed for your kind ready reference).

You are aware that any change in Bonus Act would be an indicator while deciding the Payment of Bonus in the Central Government Employees. Accordingly, every time when (Bonus Act is amended raising the payment ceiling limit, it is extended to Central Government Employees also. This issue was also raised by the Staff Side in the Standing Committee Meeting of National Council (JCM) held on 09th October, 2015.

It is therefore requested that steps may be taken for issuing Government Orders for enhancing the Bonus Payment Ceiling limit of Central Government Employees both PLB and Adhoc Bonus to Rs. 7,000/- w.e.f. 01.04.2014 and arrears of PLB and Adhoc Bonus for the year 2014-2015 may be paid to the employees.

An earlier and favorable action is solicited.

THE PAYMENT OF BONUS (AMENDMENT) ACT, 2015

NO. 6 OF 2016

[31st December, 2015.]

An Act further to amend the Payment of Bonus Act, 1965.

BE it enacted by Parliament in the Sixty-sixth Year of the Republic of India as follows:-1.

(1) This Act may be called the Payment of Bonus (Amendment) Act, 2015.

(2) **It shall be deemed to have come into force on the 1st day of April, 2014.**

2. In section 2 of the Payment of Bonus Act, 1965 (hereinafter referred to as the principal Act), in clause (13), for the words "ten thousand rupees", the words "twenty-one thousand rupees" shall be substituted.

3. In section 12 of the principal Act,-(i) for the words "three thousand and five hundred rupees" at both the places where they occur, the words "seven thousand rupees or the minimum wage for the scheduled employment, as fixed by the appropriate Government, whichever is higher" shall respectively be substituted;

(ii) the following Explanation shall be inserted at the end, namely:-

'Explanation.-For the purposes of this section, the expression "scheduled employment" shall have the same meaning as assigned to it in clause (g) of section 2 of the Minimum Wages Act, 1948.'

4. In section 38 of the principal Act, for sub-section (1), the following sub-section shall be substituted, namely:-

"(1) The Central Government may, subject to the condition of previous publication, by notification in the Official Gazette, make rules to carry out the provisions of this Act."

Dear Comrades,

I am confident, by this time you must have studied the 26-point Charter of Demands, submitted by the NJCA to the Cabinet Secretary on 10th December, 2015, circulated vide NJCA's Circular No. NJCA/2015/7th CPC dated 11th December, 2015.

As per decision of the NJCA, the following programmes have to be successfully observed by all your affiliates all over the country.

- (i) 30.12.2015 Holding demonstrations and hand over copy of the NJCA's letter dated 10.12.2015 to the Head of the Office for onward transmission to the Cabinet Secretary, demanding for Immediate settlement of the issues.

- (ii) 19-21.01.2016 3-day dharna in all the State capitals and industrial centers/ establishments for educating and mobilizing the employees.

In view of the NJCA's decision for an "Indefinite Strike", on the above cited 26-point Charter of Demands, commencing in the 1st week of March, it will be essential that, AIRF, NFIR, AIDEF, INDWF and Conference of the Central Government Employees should conduct strike ballot. It will be quite appropriate that strike ballot is taken by the 2nd week of February, 2016.

The NJCA will meet and decide about the date of issue of the Strike Notice and also about the date of commencement of the indefinite strike. In the meantime, all our efforts may be made to build up pressure on the government, so that a negotiated settlement can be reached on our demands.

I shall keep you informed about the further developments.
